

ORDINANCE NO. _____

AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF ANNVILLE, LEBANON COUNTY, PENNSYLVANIA, AMENDING § 20-102 ("DEFINITIONS"), § 20-103 ("PREPARATION OF REFUSE AND STORAGE"), AND § 20-107 ("DISPOSAL OF REFUSE") OF PART 1, REFUSE, OF CHAPTER 20, SOLID WASTE, OF THE CODE OF ORDINANCES OF ANNVILLE TOWNSHIP.

BE IT ORDAINED AND ENACTED by the Board of Commissioners of the Township of Annville, Lebanon County, Pennsylvania, and it is hereby ordained and enacted as follows:

SECTION 1. The provisions of Part 1, Refuse, of Chapter 20, Solid Waste, of the Code of Ordinances of Annville Township, are amended as follows:

- (a) Section 20-102 ("Definitions") is amended to restate the following definition:

Rubbish—solids not considered to be highly flammable or explosive including, but not limited to, rags, old clothes, leather, rubber, carpets, wood, excelsior, ashes, furniture, crockery, masonry and other similar materials.

- (b) Section 20-103 ("Preparation of Refuse and Storage") is amended as follows:

- a. Subsection 20-103.1.C ("Refuse Preparation") is restated to read:

C. Rubbish shall be stored in durable containers with tight-fitting covers.

b. Subsection 20-103.1.F (“Refuse Preparation”) is restated to read:

F. Certain materials such as scrap lumber and firewood may be stored and kept on the premises, provided they are stored in a manner which does not create either a health or safety hazard.

c. Subsection 20-103.2.E(1)(a) (“Open Storage”) is deleted and Subsection 20-103.2.E(1)(b) is renumbered as Subsection 20-103.2.E(1)(a).

(c) Subsection 20-107.1 (“Disposal of Refuse”) is restated to read:

1. No person shall hereafter dispose of any refuse collected in Annville Township, Lebanon County, except by conveyance to a disposal facility approved by the Pennsylvania Department of Environmental Protection.

SECTION 2. All other provisions of Sections 20-102, 20-103, and 20-107 of Part 1, Refuse, of Chapter 20, Solid Waste, of the Code of Ordinances of Annville Township, remain in full force and effect.

SECTION 3. SEVERABILITY. If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal, or invalid, such unconstitutionality, illegality, or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Ordinance. It is hereby declared as the intent of the Annville Township Board of Commissioners that this Ordinance would have been adopted had such unconstitutional, illegal, or invalid sentence, clause, section, or part thereof not been included therein.

SECTION 4. REPEALER. All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed.

SECTION 5. EFFECTIVE DATE. This Ordinance shall become effective _____, 2018.
