

ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF ANNVILLE, LEBANON COUNTY, PENNSYLVANIA, VACATING THE UNOPENED STREET LOCATED BETWEEN 1015 EAST MAIN STREET AND 1051 EAST MAIN STREET, AND BETWEEN EAST MAIN STREET NORTH TO LEBANON ALLEY, WITHIN THE TOWNSHIP OF ANNVILLE.

WHEREAS, the Board of Commissioners of the Township of Annville deem it to be necessary for the public convenience and for the general benefit and welfare of the public to vacate the unopened street between 1015 East Main Street and 1051 East Main Street, and between East Main Street north to Lebanon Alley, located within the Township of Annville;

WHEREAS, the Board of Commissioners of the Township of Annville are vacating the unopened street following a Petition for Vacating Unopened Alley submitted by the adjacent property owners who reside at 1015 East Main Street and 1051 East Main Street, Annville Township, Pennsylvania.

BE IT ORDAINED AND ENACTED by the Board of Commissioners of the Township of Annville, Lebanon County, Pennsylvania, and it is hereby Ordained and Enacted as follows:

SECTION 1. AUTHORITY. Pursuant to Section 57005 of the First Class Township Code, the Board of Commissioners of the Township of Annville may vacate streets, and parts thereof, which are wholly within the Township, upon the petition of a

majority of interest of the owners of property or properties through whose land such street passes if, in the judgment of the Board of Commissioners, it is necessary for the public convenience to vacate said street.

SECTION 2. The unopened street located between 1015 East Main Street and 1051 East Main Street, between East Main Street north to Lebanon Alley, located within the Township of Annville, is hereby vacated to the property owners who own 1015 East Main Street and 1051 East Main Street, Annville, Pennsylvania.

SECTION 3. SEVERABILITY. If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal, or invalid, such unconstitutionality, illegality, or invalidity, shall not affect or impair any of the remaining provisions, sentences, clauses, sections, or parts of this Ordinance. It is hereby declared as the intent of the Annville Township Board of Commissioners that this ORDINANCE would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section, or part thereof not been included therein.

SECTION 4. REPEALER. All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed.

SECTION 5. EFFECTIVE DATE. This Ordinance shall be effective November 7, 2018.
